Finally, the Attorney General transmits an annual report to the Congress on the Administration of the Act which lists the names of all agents and the nature, sources and content of the political propaganda disseminated or distributed by them. This report is available to the public.

On behalf of my client, Barron Birrell, Inc., I am forwarding herewith for filing the requisite copies of the supplemental statements for the six month periods ending May 31, 1993 and November 30, 1993, respectively. Also enclosed are two short form registration statements.

My client registered on behalf of the Hyundai Business Group/Washington office at the time of the registrant's initial registration on November 2, 1992, in connection with a project undertaken on behalf of the Hyundai Business Group several months earlier, in August 1992. (We have exchanged correspondence on the reasons for the delay in filing on behalf of this client.) My client advises that this turned out to be a one-time project for Hyundai, and that the registrant ceased all services for Hyundai even before the registrant's initial registration in November 1992. Accordingly, my client requests that this registration be terminated.



Accordingly, my client requests that this registration also be terminated.
