

Item 11, Page 4.

The Federal Republic of Nigeria. Registrant (R) continued to provide the Foreign Principal (F/P) with strategies and to plan activities to promote human rights and democracy in several of the F/P's major cities, including Lagos, Abuja, Ibadan, Kaduna and Kano. Registrant continued to provide F/P with public information regarding U.S. policies toward the F/P.

Item 12, Page 4.

The primary role played by Registrant was the promotion of democracy and respect for human rights in Nigeria. However, R did collect information on U.S. policies for the F/P. These information collection efforts did include the R attending public events (such as Congressional Hearings) and also ad hoc meetings and conversations with Congressional Staff and others. While R did not advocate a position for F/P, the R did advise these individuals as to its first-hand understanding of the democracy and human rights situation in Nigeria.
