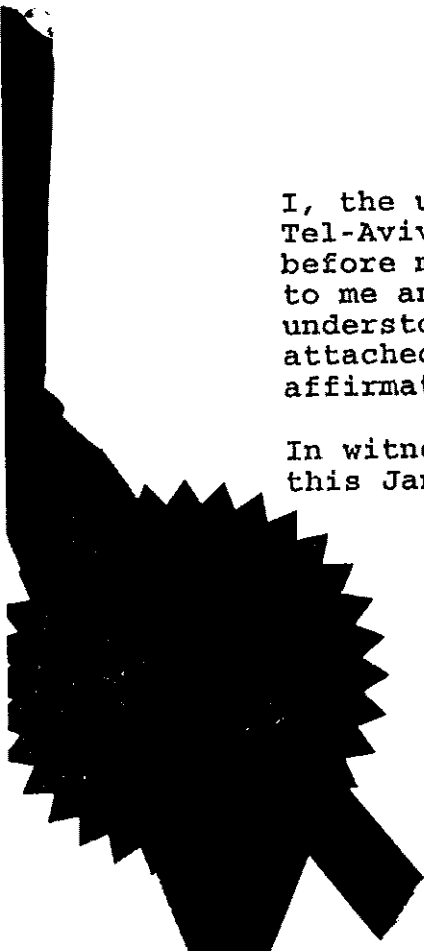

Renewal of Agreement between URDAN INDUSTRIES LTD and ZVI RAFIAH.

An extension of the agreement between URDAN INDUSTRIES LTD. and ZVI RAFIAH was signed by the parties on January 2nd, 1994 for the duration beginning on January 1st, 1994 until December 31st, 1994.

The agreement is identical to the previous one (which ended on December 31st 1993), except for the following changes:

Paragraph 5, a: 1600 (sixteen hundreds) replace 1000 (one thousand).

paragraph 5, c, reads as follows:

A commission of 0.75% from the net payment that URDAN will get from any order that URDAN received, and concerning which URDAN had requested, in writing, the consultant's assistance, prior to its (the order) receipt at URDAN. The date which appears on the order, when checked against the date of the specific address of URDAN to the consultant, will serve as a decisive proof concerning the abovesaid commission.

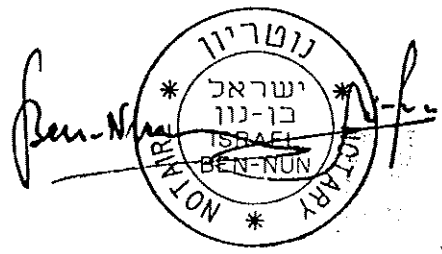
The previous Paragraphs 5, d , e , are deleted.
