

Registrant will be working with the Government of Haiti for a projected four month period. During this period, she will be compensated with a monthly salary of \$5,000. Registrant will be reimbursed for living expenses (\$940.00) while in Washington, D.C.

Registrant will assist the Government of Haiti in its efforts to restore the democratically elected government of Haiti. Towards this end, Registrant will implement directives given by Jean-Bertrand Aristide, President of the Republic of Haiti and by other members of the Government of Haiti.


5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Pursuant to directives given by President Aristide, Registrant may accompany President Aristide when he meets with Members of Congress and their staff; Registrant may meet with staff members of Congress with or without President Aristide; Registrant may be asked to do initial drafts of letters and correspondence; Registrant may be asked to draft notes for the preparation of speeches to be delivered by President Aristide.
