

Registrant's duration is indeterminable; its expenses will be defrayed by the Government of Haiti as such expenses are approved and incurred.

Registrant will engage in a variety of informational activities vis-a-vis third parties with a view towards garnering support for its goals. Among other things, registrant's agents may meet with U.S. legislators or other U.S. officials and/or members of their staff and other private third parties. Registrant's agents will provide to third parties information orally, by letter and through materials which may be deemed to be political propaganda.

5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.
