



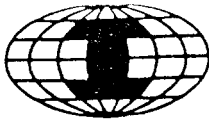

Preamble

After consultations with Intertanko Management, Mr. Ole Skaarup, and a number of other possible clients, Mr. W.O. Gray (WOG) has decided to form his own company effective January 1995, probably to be named Gray Maritime Company (GMC). WOG will be the only staff, at least initially. WOG will inaugurate GMC with its main clients being Intertanko for half of WOG time over the next two years, and the Skaarup Group also as a main GMC client. The possibility of adding additional clients exists. Work for new clients will not conflict with the interests of any existing clients, Intertanko, Skaarup, or others.

Conditions under which WOG will be retained by Intertanko are described below.

Intertanko/W. O. Gray Agreement

1. Mr. W.O. Gray (WOG) is to be engaged as a Consultant with Intertanko as from 1 January, 1995 for a period of two years, ending 31 December, 1996.
2. WOG agrees to provide Intertanko half of his full working time. Given a U.S. full-time working schedule of 225 eight-hour days per year, after allowance for holidays, vacation, etc., this will amount to 900 hours per year for Intertanko. Occasional travel time, outside of daily working hours and during Saturdays and Sundays will not count as working hours.
3. WOG remuneration from Intertanko will be U.S.\$135,000 per annum, which will be paid as twelve monthly installments of \$11,250 by the last working day of each calendar month. WOG remuneration will cover his profit, and all normal non-travel working expense including fully outfitted office, secretarial assistance, communication and office equipment, and other business expenses such as supplies, mail, telephone, facsimile, and communication expense generally.
4. WOG travel expenditures on Intertanko business will be reimbursed by Intertanko monthly on presentation of reasonable travel and living expenses, including flights at Business Class.



5. WOG is to assist INTERTANKO in accordance with instructions from Mr. Tormod Rafgård (Managing Director) or by Mr. Trygve A. Meyer (Director). To facilitate work tasks and priorities, due regard should be taken of the current Strategy and Action Plan based on decisions/recommendations made by INTERTANKO's Council, Executive Committee and ISTEAC.
6. WOG's first task should be to analyse the safety risks at U.S. oil ports and terminals and provide a plan for INTERTANKO on how to improve the conditions of the various ports and terminals. WOG knows that OPA COFR liability issues should continue to be dealt with by Haight and Gardner, and that Contingency plan issues should continue to be dealt with by Mr. Charles Corbett. WOG will resign from INTERTANKO OPA '90 Committee, but will continue to receive OPA Committee communications, and participate at INTERTANKO's request.
7. WOG's work includes preparing meeting agendas, submissions to USCG and other bodies as appropriate, and attending meetings as instructed. WOG will also act on liaison tasks on behalf of INTERTANKO and prepare and present speeches and, as applicable, participate in meetings and make presentations in various fora, as agreed with the Managing Director.
8. Approaches to U.S. government representatives, or U.S. industry bodies should always be authorised by INTERTANKO's Managing Director, who should be kept fully informed of any dialogue that takes place. WOG agrees to keep Haight, Gardner and Mr. Charles Corbett fully informed about his activities as they relate to tasks for INTERTANKO, and understands that Messrs. Haight, Gardner and Charles Corbett will similarly keep WOG informed on their activities relating to INTERTANKO.
9. WOG will, during his efforts, always keep in mind that there will be areas in which individual INTERTANKO members have different views, and other areas in which INTERTANKO has established public positions. WOG should, at all times, respect these positions.
10. While conducting work for INTERTANKO WOG will use INTERTANKO stationery and identification and, for that purpose, INTERTANKO agrees that WOG's title should be Marine Advisor to INTERTANKO.
