

JWI will work with the Client to obtain all information necessary in order to prepare the formal GMA filing, and will engage with US Government Officials about the Client's GMA application.

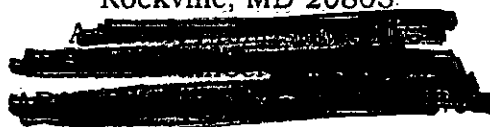
FEES

Should JWI's activities result in the exoneration of the Client before the expiration of the six month term of this agreement, Client will not be held responsible for one or more of the due payments per the original contract.






TERMS
