



CONTRACT


The Embassy of Japan, 2520 Massachusetts Avenue, N.W., Washington, DC(hereinafter referred to as the "Embassy") and Decision Management, Inc., 2010 Corporate Ridge, McLean, VA (hereinafter referred to as the "DMI") have agreed as follows:

1. The DMI agreed to provide the Embassy with two reports on Analysis of the 1994 Congressional Elections, due on January 15,1995 and a longer-term view during the 104th Congress period (1995-96), due on March 15,1995.
2. The Embassy agrees to pay the DMI \$ 10,000 (Ten Thousand Dollars) in total, with \$5,000 upon receipt of the first report and the rest upon this project's completion.
3. The report and its contents shall be the property of the Japanese Government. The DMI shall not disclose the contents of the reports to any third party without the expressed permission of the Japanese Government.
