While drafts of agreements were circulated, we eventually came to an oral agreement regarding the nature and scope of the work. We agreed to a one-month term to monitor US-Taiwanese relations around the time President Lee was seeking entry into the U.S.

- 4. Describe fully the nature and method of performance of the above indicated agreement or understanding.

We agreed orally to monitor on a month-by-month basis at a fee of \$17,500 per month. We also orally agreed that the client would reimburse our travel expenses of \$10,000 for an April trip to Taiwan. The agreement was terminated after approximately 20 days of the first month and we agreed that we would receive the full month's fee of \$17,500. It was received in July, 1995.


We were to monitor US-Taiwanese relations and current events and report back on a regular basis.
