During this time period, Friends of Sinn Féin, Inc. received a total of \$406,133.80. This total was comprised of \$405,373.80 received in check donations, and \$760.00 in cash. Checks in the amount of \$50 or more accounted for \$404,597.80. Checks in amounts less than \$50 amounted to \$776.00. Cash in amount of \$50 or more accounted for \$760.00. Cash in amounts less than \$50 amounted to \$0.00.


