It constitutes the account of all money collected and deposited from Nov. 1, 2011 through April 30, 2012 as a result of the Registrant's fund-raising campaign and reflects all money transmitted to the foreign principal, pursuant to Rule 201(e).

All monies received, were for the purpose of supporting the activities and purposes of Sinn Fein as a democratic political party engaged in Ireland and in many countries throughout the world in promoting the Irish Peace Process by social welfare, educational and lobbying activities.

During this time period, Friends of Sinn Fein, Inc. received a total of \$412,740.97. This total was comprised of \$412,640.97 received in check donations, and \$100 in cash. Checks in the amount of \$50 or more accounted for \$412,377.97. Checks in amounts less than \$50 amounted to \$263.00. Cash in amount of \$50 or more accounted for \$100. Cash in amounts less than \$50 amounted to \$0.
