## **EDUCATION AND ENGAGEMENT**

In an effort to help create and share more accessible resources for learners and people curious about Irish Unity, we started the Irish Unity Education Webinar Series. It's a monthly webinar with a different guest each month. The conversations last around an hour and the focus is on learning more about the many aspects of the work being done to create a new and united Ireland. So far we've featured Glenn Bradley, Colin Harvey, and Ben Collins. Plans are underway for more guests. Feedback on these events and the recordings has been overwhelmingly positive.

## **STUDY GROUP**

After some difficulty getting copies of our first choice of a book (Brendan O'Leary's *Making Sense of a United Ireland*) we decided to switch to Ben Collins' *The Irish Unity Dividend* because it is not only a more accessible read, but it is far easier for everyone to get a copy. The goal of this subcommittee is to create a study guide that will be first used with volunteers from this group, then shared with other groups who may want to host their own study group as well as with a larger group of learners and readers.

## **NORMS\***

We are a great group and have been lucky so far on our calls with focus, brainstorming, learning, and sharing in ways that are constructive and respectful. It would be great to keep it that way, and in order to set ourselves up for success, I would love to set up a small, temporary group to work out some group norms.
