Washington World Group and Cohen and Woods International will contract with the Government of the Democratic Republic of Congo to provide consulting, public relations, government relations and strategic planning services.


During the first year of the contract, the two firms will concentrate on the following:

- * Provide a level playing field for reporting on and analysis of the civil war currently taking place in DROC;
- * Convey a clear picture of political and economic trends as well as future potential of the DROC;
- * Encourage and support efforts by the international community, especially the USG, to promote a dialogue between the DROC Government and Congolese political groupings, civil society and the private sector in order to bring about national reconciliation and a democratic political transition.
- * Encourage increased contact between the American private sector and the DROC private sector with a view to expanding trade and investment.
