A previous registration for the Ministry of Oil was terminated by an amendment to the firm's registration statement on December 30, 1982 on the assumption that further legal services for this principal would be exempt from registration. Through a change of circumstances, however, the firm has now determined that it may be called upon to provide additional legal services to the foreign principal in 1983 which could be regarded as requiring reinstatement of registration for this principal.


