

ATTACHMENT

CSR Limited

Registrant acts as counsel to CSR Limited, marketing agent for the Queensland Sugar Board. In this capacity, during the period registrant advised the Company with respect to regulations concerning the U.S. sugar market and with respect to administrative and legislative proposals relating to the U.S. sugar market.

Registrant participated in meetings with officials of the Foreign Agricultural Service in the Office of International Affairs and Commodity Programs at the Department of Agriculture, the Office of Trade and Commercial Affairs (Food Policy and Programs) at the Department of State, and Office of the U.S. Trade Representative on September 1, 1982 and October 8, 1982, and with officials of this same office of the Department of Agriculture on November 10, 1982, with respect to matters concerning the operation of regulations relating to the U.S. sugar market.

In addition, during the period registrant advised the Company as to the legislative status, including congressional committee hearings, of the proposed Caribbean Basin Initiative ("CBI"). In this connection, registrant engaged in contacts with staff members of the Senate Finance Committee for the purpose of obtaining information regarding the status of the proposed CBI legislation.

Registrant also advised the Company during the period with respect to the status, including congressional committee hearings, and ultimate enactment of legislation to extend U.S. membership in the International Sugar Agreement.
