(2) Remuneration: Seven thousand dollars (\$7,000) for the above reports, payable in the amount of thirty-five hundred dollars (\$3,500) on or about September 30, 1963, when the first report will be due and the balance of thirty-five hundred dollars (\$3,500) on or about December 31, 1963, when the final report will be due.
