The Embassy of Japan may desire advice on certain legal matters from the law firm of Cleary, Gottlieb, Steen & Hamilton from time to time during the period April 1, 1965 through March 31, 1966. Any matters to be worked on by the law firm will be determined by mutual agreement between the Embassy and the law firm. It is agreed that the fees and disbursements for services requested and rendered pursuant to such mutual agreement will be billed periodically on the basis of time spent in performing such services and will not exceed Twenty-Four Thousand Dollars (\$24,000) during the period.
