

Each partner, officer, director, associate, employee, and agent of a registrant is required to file a short form registration statement unless he engages in no activities in furtherance of the interests of the registrant's foreign principal or unless the services he renders to the registrant are in a secretarial, clerical, or in a related or similar capacity.

Privacy Act Statement. The filing of this document is required by the Foreign Agents Registration Act of 1938, as amended, 22 U.S.C. § 611 *et seq.*, for the purposes of registration under the Act and public disclosure. Provision of the information requested is mandatory, and failure to provide this information is subject to the penalty and enforcement provisions established in Section 8 of the Act. Every registration statement, short form registration statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the Registration Unit in Washington, DC. 

Kristin joined Innovation Norway New York in January 2007 as Director of Tourism Americas. As of fall 2007, she also took on the position as the Region Director of Innovation Norway Americas, covering trade and tourism.

Her job description includes various activities for Innovation Norway, such as supervision and administration of employees both in the large trade section and in the much smaller tourism section. Her job is on an overall management level and does not include any project work or marketing activities. Her tasks include employee training, team building, strategic & organizational development, and the annual reporting of the operation back to Innovasjon Norge in Oslo. Her job is also to work with the Norwegian Ministry of Foreign Affairs and to act as a liaison between the two organizations on mutual topics of interest by staying in close contact with the Norwegian Embassy and Consulates.
