As of Jan. 1, 2004 Innovation Norway became the successor of Norwegian Tourist Board. The name "Norwegian Tourist Board" continued to be used intermittently for the organization. The "Innovation Norway" name was not used on the 2004 Supplemental Statements. In the Supplemental Statement for the period ending June 30, 2005 the organization filed under the name "Norwegian Tourist Board/Innovation Norway" for the first time, but inadvertently omitted to check "yes" to question 2(b)(1) above. It continued to file under the name "Norwegian Tourist Board/Innovation Norway" until the Supplemental Statement for the period ending June 30, 2007, when it filed under the name "Innovation Norway". The organization now continues to operate under the "Innovation Norway" (or in Norwegian, "Innovasjon Norge") name.



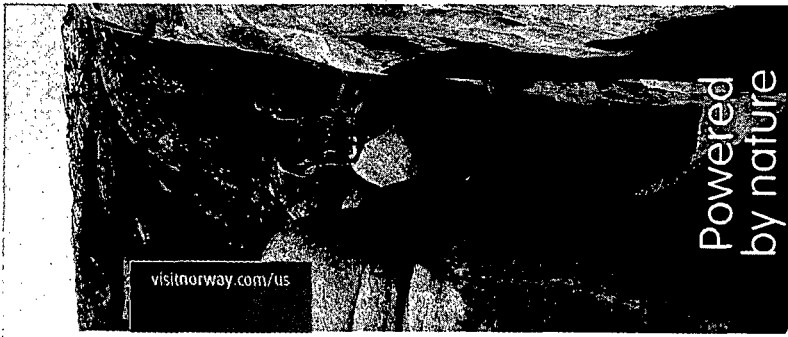
