(DMRI) engages in activities as contained in the legislatively endorsed agreement between DMRI and the Government of Dominica dated 1 October 1999, as amended. The original agreement was filed with the Registration Statement of the Commonwealth of Dominica Maritime Registry Inc. (Reg No. 5334) on 12 October 1999. IN accordance with the agreement, DMRI administers the maritime and related corporate program on behalf of the foreign principal.

Primary activities engaged in accordance with the agreement, include management and promotion of the Dominica Flag State as the "Flag of Responsibility", preparation of official documents relating to Dominica vessels and seafarers, and ensuring Dominica vessels comply with Dominica and international law.
