

Those policies and issues of concern to the Government of Morocco include, most importantly, the enhancement of U.S.-Moroccan relations in the political, security, and economic spheres; the promotion of stability and cooperation in Morocco's relations with its neighbors in southern Europe, West Africa, North Africa, and the broader Middle East; and finding a solution to the dispute over Western Sahara. At the request of the foreign principal, meetings with Members of Congress and their staff, as well as with Executive branch officials, multilateral institutions, and non-governmental organizations will likely be arranged.


This document will serve to confirm and memorialize the terms of the agreement reached today between the Ministry of Foreign Affairs for the Kingdom of Morocco, hereinafter referred to as "MoFA," and The Livingston Group, LLC, hereinafter referred to as "TLG."

- It has been agreed that TLG has been engaged by MoFA for the purposes hereinafter described, with said engagement to be effective March 1, 2005, and extending for a period of 12 months thereafter to February 28, 2006, unless the relationship shall be extended and/or renegotiated by the parties.
- The compensation to be paid to TLG shall be five hundred thousand (\$500,000) U.S. DOLLARS per term of the contract, payable at the beginning of the contract term.
- With prior approval, MoFA agrees to pay extraordinary out-of-pocket expenses incurred by TLG, including airfare, travel and unusual entertainment expenses. Separate monthly invoices shall be submitted to MoFA for any such itemized expenses.
- The obligation of TLG --- by and through the counsel and activities of Robert L. Livingston, Andrew P. Ireland, Anthony J. Moffett, Jr., David Lonie, Dana Bauer, Lauri Fitz-Pegado, and Melvin Goodweather --- will be to represent MoFA as permitted by the Foreign Agents Registration Act of 1938, the Ethics Reform Act of 1989, and other applicable United States laws and regulations. TLG shall provide MoFA with government affairs representation before the government of the United States and the United States Congress, international organizations, and governments other than that of the United States, as required.
- TLG agrees to abide by every applicable law or regulation covering government contracts for lobbying during the implementation of this agreement. TLG is an independent contractor, and, as such, has no authority to bind MoFA in any manner whatsoever, absent to the express written consent of MoFA. TLG shall be solely responsible for the acts of its employees and/or agents and shall defend and hold MoFA harmless from any claims which arise from said acts. TLG shall be responsible for notifying MoFA of any potential conflicts between its representation of MoFA and any other party.
- MoFA has no authority to bind TLG in any matter whatsoever, absent the express written consent of TLG. MoFA shall be solely responsible for the acts of its employees and/or agents and shall defend and hold TLG harmless from any claims which arise from said acts.




