



MEMORANDUM OF AGREEMENT

The Government of the Islamic Republic of Pakistan hereby retains Van Scoyoc Associates, Inc. as consultants and advisors with regard to various federal agency and legislative issues involving the Government of the United States. Van Scoyoc Associates undertakes to monitor and evaluate these issues and to advise The Government of the Islamic Republic of Pakistan on the components of an administrative and legislative plan and the appropriate strategy necessary to achieve the goals of such a plan. Van Scoyoc Associates will perform such services with regard to these issues as are mutually agreed to between Van Scoyoc Associates and The Government of the Islamic Republic of Pakistan.

It is understood that Van Scoyoc Associates may be required to register under the Foreign Agents Registration Act of 1938, as amended (22 U.S.C. & 611 et seq) on behalf of the Government of the Islamic Republic of Pakistan.

In consideration of the performance of these services, The Government of the Islamic Republic of Pakistan shall pay to Van Scoyoc Associates the sum of \$30,000.00 per month during the months of May, June and July 2005 and \$40,000.00 per month during the remainder of the Agreement with such payments due monthly.

This Agreement shall become effective May 9th 2005. The Government of the Islamic Republic of Pakistan and Van Scoyoc Associates shall each have the right to terminate this agreement with 15 days notice until August 8, 2005. Subsequent to August 8, each party shall have the right to terminate by written notice given to the other party 90 days prior to the proposed date of termination
