Dear Farhad:

We are delighted that the Kurdistan Democratic Party has agreed to retain Barbour Griffith & Rogers, LLC. (BGR). Pursuant to our earlier discussions, please accept this letter of agreement to work on your behalf.

**Scope of Work:** As we discussed, our representation will include providing strategic counsel and tactical planning on legislative, regulatory and political matters before the U.S. Government.

**Fees, Terms & Expenses:** In consideration for the services provided by BGR, Kurdistan Democratic Party agrees to pay BGR an annual fee of US\$262,500 for services between June 1, 2004, and February 28, 2005. This fee is inclusive of expenses and will be payable in monthly installments of US\$29,166.67 each.

**Invoicing:** BGR will invoice the Kurdistan Democratic Party on the first day of each month for professional fees in advance of the coming month, starting June 1, 2004.

Regardless of the ultimate duration of the Agreement, all invoices generated from the terms and between the two parties to this agreement are payable in-full and promptly upon receipt and shall be paid directly to BGR.

**Renewal & Extension:** This contract can be renewed and extended upon notice by either party to the other and upon agreement of both, beyond the set termination date for a mutually agreed-upon term commencing on the first day following the previous contractual termination date. Terms and Scope of Work will remain materially and substantially the exact same as before, unless otherwise agreed to by the parties in writing.

**Termination & Cancellation:** Either BGR or the Kurdistan Democratic Party will be able to terminate the agreement for any reason upon thirty (30) days written notice, with no further obligation, other than to pay such fees and expenses that would have accrued up to and through the 30-day notice period.


