Your Excellency:

We are delighted that the Ministry of Finance, Federal Republic of Somalia ("Somalia") has agreed to retain BGR Government Affairs, LLC ("BGR"). Please accept this letter of agreement ("Agreement") to work on its behalf.

**Scope of Work:** BGR will serve as a liaison for Somalia in the United States and assist Somalia with its efforts to strengthen relations between U.S and the Federal Republic of Somalia.

**Fees & Term:** In consideration for the services provided by BGR, Somalia agrees to pay BGR a monthly professional fee of USD\$35,000.00 for services beginning May 1, 2018 through December 31, 2019. The fee will be paid in equal quarterly installments in advance of the coming quarter. The first quarterly fee is due upon execution. Additionally, Somalia agrees to reimburse BGR for ordinary and out-of-pocket expenses, including items such as international and domestic airfare, lodging, non-local transportation, meals and other incidental expenses; however, these will be authorized by Somalia in advance.

**Invoicing:** Professional fees and expenses are invoiced separately:

1. **Professional Fees:** Upon execution, BGR will invoice Somalia for service provided from May 1, 2018 through July 31, 2018 is attached and due upon execution of this agreement. Thereafter, BGR will invoice Somalia on first day of the quarter beginning August 1, 2018.

2. **Expenses:** BGR will invoice Somalia on the last day of each month for expenses incurred during the month prior, starting May 31, 2018.

**Termination & Cancellation:** Either BGR or Somalia may terminate the Agreement for any reason upon ninety (90) days written notice, with no further obligation, other than for BGR to perform necessary work for the term and Somalia to pay such fees that have accrued up to and through the 90-day notice period.

**Confidentiality:** BGR recognizes that in the course of our representation, we could become aware of information, practices or policies, which you wish to be kept confidential. BGR agrees to maintain that confidentiality and will not disclose to any outside party the
