I'm reaching out on behalf of Nobel Peace Prize recipient and Ukrainian human rights lawyer [Oleksandra Matviichuk](#).

Oleksandra is based out of Kyiv but has been visiting Washington over the last several months to meet with members of Congress, administration officials and members of civil society to share the latest report from the war in Ukraine. You may have also [seen](#) her [TV ads](#) recently on [cable](#) news.

She will be in DC this **February 2-11** and can provide the latest on-the-ground report from Ukraine as well as provide detail on the atrocities being committed by Vladimir Putin and his army against innocent civilians and the persecution of Christian leaders and churches in eastern Ukraine. Her organization has documented more than 80,000 Russian war crimes.

Some background on Oleksandra and the work she's doing:

- Oleksandra is based in Kyiv and heads the [Center for Civil Liberties](#), a human rights organization that received the 2022 Nobel Peace Prize.
- Oleksandra was recognized as one of the [top 25 most influential women in the world](#) by the Financial Times in 2022.
- At the start of the war in February 2022, Oleksandra created the "[Tribunal for Putin](#)" initiative with other partners to document international crimes under the Rome Statute of the International Criminal Court in Ukraine.
- Through her work with the Center for Civil Liberties and the Tribunal for Putin, Oleksandra has cataloged [approximately 80,000 Russian crimes](#) over the last decade.

We'd love for a meeting to work out – we are very flexible and can work around Sen. Barrasso's schedule.
