
CONSULTING AGREEMENT
between
THE GALLAGHER GROUP, LLC
and
Qorvis Communications, LLC

1. **Services to be Rendered:** As an independent contractor The Gallagher Group, LLC agrees to provide government relations services to Qorvis Communications, LLC on behalf of the Royal Embassy of Saudi Arabia which shall include but not necessarily be limited to: (1) the development of an overall governmental relations strategy; (2) contacts with members of Congress, their staffs, and senior officials from the Executive Branch of the federal government; and (3) assistance in the preparation of briefing materials.
2. **Fee:** For the services rendered by the Gallagher Group, LLC, in accordance with this agreement, Qorvis Communications on behalf of the Royal Embassy of Saudi Arabia shall pay the Gallagher Group a fee of twenty thousand dollars of which ½ of the total fee is payable upon signing of the agreement and ½ is payable on January 31, 2002.
3. **Term:** This agreement shall be in effect from November 15, 2001 through February 15, 2002.

This contract contains the entire agreement between the Gallagher Group and Qorvis Communications regarding this matter and fees, charges and expenses relating thereto. This agreement shall not be modified except by written agreement signed by the Gallagher Group and Qorvis Communications. Each provision of this agreement shall be severable and if any provision is determined by a court to be invalid or unenforceable, the validity of the remaining provisions shall not be affected thereby.

4. The Gallagher Group makes no assurances or warranties regarding the outcome of any matters, nor the amount or likelihood of any funds or awards resulting from the undertakings described in clause one (1) of this contract.
5. This agreement shall be subject to the provisions of the Procurement Integrity Act, The Lobby Disclosure Act of 1995, and all other applicable laws and regulations governing contacts with the United States Congress and covered Executive Branch Officials; and shall be subject to the laws of the Commonwealth of Virginia.
