We are responsible for the issuance of the Certificates and the collection of fees for the vessels and NVOCC and Shippers and transfer same to the CNC in Angola. We also keep records on all issued Loading Certificates.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Type Loading Certificates and issue to the shippers, process and stamp the cargo manifest and return same to the vessel's owners. collect the fees from the shippers, NVOCC, and vessels. Keep records of the Loading Certificates and send twice monthly statements of activities and transfer of funds to the CNC Angola.


