Medley Global Advisors has an oral agreement with the Government of Mexico to provide communication and public opinion strategy to President Fox via Redes, the Fox Office of the President Director of Public Opinion and Communication, and the Foreign Minister.

An oral agreement was reached with the Presidential staff, Mr. Ocampp, and the Foreign Minister. The Government of Mexico has agreed to pay MGA up to \$13,000 per month from August 1, 2001 to the present date.
