Pursuant to the Foreign Agents Registration Act of 1938, as amended

Section 3. Donations to the BNP from the AFBNP.

8/2/2000 \$500.00 to the Black Country branch of the BNP, towards their by-election campaign in West Bromwich.

10/5/2000 \$500.00 to the North West branch of the BNP towards their by-election campaign in Preston.

11/10/2000 \$788.22 (converted to 500 UK pounds) to the National BNP office, towards their by-election campaign in West Bromwich.

Note. The TV/Press reports that the AFBNP raised \$85,000 to \$200,000 are of course complete and utter lies, as our tax returns for 1999, 2000 and 2001 clearly show that we raised only a fraction of this and of that fraction, only \$1,788.82 went directly from the AFBNP to the BNP.

The funds the AFBNP raised came in as donations from our members and supporters who wished to finance the AFBNP (to carry on its work as an American organization) and not the BNP. If AFBNP members/supporters or any American for that matter wanted to give money to the BNP, we would give them advice on how to do that themselves, although in most cases Americans would just get on and do it on their own. The BNP has a Visa/MasterCard Donation form on its website and Americans (or anybody else for that matter) can just get on line and send them personnel donations of up to 200 UK pounds anytime they like. Those who do not have Internet and/or credit cards can donate to the BNP by means of mailing them a check or International Money order direct to the BNP's UK address. During the UK General Election campaign of May/June 2001, the BNP received around \$4,000 from American supporters. We do not have the exact figures, as these donations were sent by American individuals and not the AFBNP.

Although not completely relevant to this it should still be noted that the BNP was completely cleared by the British Electoral Commission of the allegation that it accepted impermissible donations from the AFBNP. (See attachment number 3).
