This form is to be used for statements filed as Exhibit C to registration statements under section 2 of the Act on Forms FA-1 and FA-2 and supplemental statements on Forms FA-1-6M and FA-2-6M. Every Exhibit C shall be filed in duplicate.

If an exhibit on this form has previously been filed in regard to the foreign principal, the exhibit currently being filed need contain only so much of the information required by this form as may be necessary to complete and bring up to date the information previously furnished.

Additional copies of this form may be obtained from the Foreign Agents Registration Section of the Special War Policies Unit of the Department of Justice.

1. (a) State the name and principal business address of the foreign principal to whom this exhibit relates.

- (b) State the names and addresses of all branches or other local units of the foreign principal in the United States and, unless a business organization or a government of a foreign country, the names and addresses of all branches or other local units outside the United States.

2. If the foreign principal is an individual, give the following information:

(a) All residence addresses in the United States and elsewhere.

(b) Citizenship or nationality.

(c) If the foreign principal is an officer, employee or agent of a government of a foreign country or of an official or agency thereof, give the name of such government, official, or agency and fully describe the office, employment, or duties as agent.

(d) If the foreign principal is not an officer, employee, or agent of a government of a foreign country or of an official or agency thereof but is in any way affiliated or associated with or supervised, directed, controlled, financed, or subsidized in whole or in part by any such government, official, or agency, explain fully.

(c) Names and principal business addresses of all partners, officers and directors, or persons performing similar functions.

(d) The extent, if any, to which the foreign principal is supervised, directed, owned, controlled, financed, or subsidized in whole or in part by any government of a foreign country, any foreign political party, or any official or agency thereof.
