We were engaged for this assignment by Venable LLP. The agreement had a two-month duration for April and May of this year. The Prime Minister had originally intended to visit this country in May. His visit did not occur until October, therefore, our engagement was extended. Our task was to provide media advice and to prepare and "op-ed" piece. We also arranged a press breakfast.

We engaged Creative Response Concepts, which is located at 2760 Eisenhower Avenue in Alexandria, VA, to set up the press breakfast and to seek interview opportunities. We paid them \$10,000 for work that they performed in April and May of this year with respect to the first task. We engaged them for the same work in October when the Prime Minister visited Washington. We also engaged the Pinkston Group, which is located at 2760 Eisenhower Avenue in Alexandria, VA, to edit an "op-ed" piece.


