Your Excellency:

The purpose of this letter is to amend the terms of the Consulting Agreement dated August 27, 2018 ("Original Agreement") between FGS Global (US) LLC ("Consultant") and the Ministry of Foreign Affairs, Republic of Somaliland ("The Somaliland Government"), as amended (collectively, the "Agreement").

Terms of service

We mutually agree to continue our services beyond the term of our Agreement. This contract amendment ("Amendment #11") involves our performing further professional services for The Somaliland Government through December 31, 2025. This Amendment #11 shall be effective as of May 1, 2025.

Rights under Agreement

All rights and obligations of both parties under the Agreement shall remain in full force and effect, except as explicitly modified or amended in this Amendment #11.

Modifications to Agreement


*Section 8(a) of the Agreement, "Monthly Fee", shall be replaced with the following:*

- a. Monthly Fee. To secure Consultant's involvement in providing the services described in Section 1 of the Agreement through December 31, 2025, The Somaliland Government shall pay Consultant a \$24,500 non-refundable fee for services performed during May 2025, a \$24,500 non-refundable fee for services performed during June 2025, and a \$29,000 per month non-refundable fee for services performed from July 1, 2025 through December 31, 2025. Consultant shall be responsible for invoicing The Somaliland Government.
