The purpose of this letter is to amend the terms of the Letter of Agreement dated October 18, 2019, as amended ("Agreement"), between FGS Global (US) LLC ("Consultant") and Permanent Mission of the United Arab Emirates to the United Nations ("the Mission").

Terms of service

We mutually agree to continue our services beyond the scope of our Agreement. This contract amendment ("Amendment #8") involves our performing further professional services for the Mission through ~~June 22May 14~~, 2026. This Amendment #8 shall be effective as of ~~June 23May 15~~, 2025.

Rights under Agreement

This letter shall be an extension to our Agreement and all rights and obligations of both parties under the Agreement shall remain in full force and effect, except as explicitly modified or amended in this letter.

Additional Modifications to Agreement

Effective as of ~~June 23May 15~~, 2025:

- Following a hiatus between March 1, 2025 and ~~June 22May 14~~, 2025, the end date shall be updated to note ~~June 22May 14~~, 2026.
- *Section 1 ("Advisory Duties") shall be replaced with the following:*

1. Advisory Duties. Consultant shall devote such time and effort in performance of its duties as may reasonably be requested by the Mission. Consultant shall be available to meet with the Mission or its representatives on a regular basis. Consultant's duties under this Agreement shall include:
 - a. Delivering senior strategic counsel on communications matters.
 - b. Developing strategic communications campaigns to guide the Mission's policy priorities.
 - c. Supporting the Mission's response to unanticipated, emerging issues and press inquiries.
 - d. Providing counsel and proactive planning for Mission leadership engagements, including tactics, trips, media, and event participation.
 - e. Updating and refining messaging and content on the Mission website.
 - f. Providing on-the-ground staffing during critical moments requiring increased capacity.

- Section 3.a. ("Monthly Fees") shall be replaced with the following:

- a. **Monthly Fees.** In complete consideration for the mutually agreed upon services listed in Section 1 of this Agreement, the Mission shall pay Consultant a \$55,000 (fifty-five thousand dollars) per month fixed fee between ~~June 23~~ **May-15**, 2025 and ~~June 22~~ **May-14**, 2026.
