Footnote: Political activity as defined in Section 1(o) of the Act means any activity which the person engaging in believes will, or that the person intends to, in any way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of a government of a foreign country or a foreign political party.

Agreement

This agreement is made between Taipei Economic and Cultural Representative Office in the United States hereafter referred to as TECRO and Rosemont Associates, L.L.C., a New Jersey company, hereafter referred to as the Firm.

The parties have agreed as follows:

1. The agreement is for a twelve-month period, from January 1, 2005 through December 31, 2005.
2. The Firm shall receive a monthly fee of US\$15,000.00.
3. The Firm shall carry out all its activities within the framework of this agreement under the direction and supervision of TECRO.
4. The Firm will invite Members of the United States Congress to visit Taiwan.
5. The Firm will attempt to persuade the Congress to act favorably on legislation of interest and benefit to Taiwan.
6. The Firm will assist TECRO to establish and maintain contact with the Members of Congress, relevant Committees and key staff.
7. In the course of its representation of TECRO, the Firm agrees that it will act in conformance with all applicable United States laws and regulations.
8. This agreement shall be construed in accordance with and governed by the laws of the District of Columbia. Any suit against TECRO arising out of this agreement shall be filed in the United States District Court for the District of Columbia pursuant to the Foreign Sovereign Immunities Act, 28 U.S.C. Section 1602 et seq. TECRO does not waive any right it may have to sovereign immunity in that court. Service on TECRO must be made pursuant to 28 U.S.C. Section 1608 (a)(4) through the US Department of State. Each party will bear its own costs and attorney's fees.
9. Any reports prepared by the Firm for TECRO shall be considered

confidential and not for distribution to any third party. On request, the Firm will deliver all copies, in any form whatsoever, and all copies of any documents received to TECRO.

10. The Firm shall deliver to TECRO a Monthly Activity Report on or before the 10th day of each month. This Activity Report shall contain all activities undertaken on TECRO's behalf, for the previous month.
11. TECRO shall reimburse the Firm for all travel expenses incurred for any travel outside of the Washington, DC metropolitan area undertaken at TECRO's request and permission.
12. The Firm agrees to promptly notify TECRO if it decides to represent the government of the People's Republic of China PRC , that is, the state itself, or any subdivision or agency or instrumentality thereof, as those terms are defined in 28 U.S.C. 1603(a) and (b), during the term of this agreement.
13. Either party may terminate this contract on 30 days written notice for any reason.

Memorandum

To: Representative David Lee, TECRO
Fr: Sen. Robert Torricelli, Rosemont Associates
Re: Workplan for Upcoming Year
Dt: January 17, 2004

This memorandum or "Workplan" includes some of the activities that former Senator Robert Torricelli proposes to act upon for TECRO. This is not an exclusive list, as Sen. Torricelli and TECRO work on various assignments, ~~additional matters may be~~ added to the Workplan at TECRO or Sen. Torricelli's direction.

The basic elements of the Workplan are as follows:

1. Sen. Torricelli will monitor and analyze Congressional activity as it relates to legislation and/or resolutions under consideration by the U.S. Congress that may affect R.O.C. - U.S. relations. Additionally, Sen. Torricelli will assist TECRO in its efforts to invite Members of the U.S. Congress to visit Taiwan, ROC, during the upcoming year.
2. Sen. Torricelli will provide political commentary and other appropriate support for ROC dignitaries visiting the U.S. In particular, Sen. Torricelli will assist in arranging meetings with Congressional leaders and key individual members of the U.S. House and Senate as requested or approved by TECRO.
3. Sen. Torricelli will monitor and analyze actions, discussions, and policy initiatives of the Bush Administration as it relates to the ROC. Attention will also be paid to U.S. relations with other nations in the Pacific region, most particularly The People's Republic of China. Sen. Torricelli will assist TECRO in tracking visits by members of the Bush Administration to the PRC and visits to the U.S. by prominent PRC leaders.
4. Sen. Torricelli will assist TECRO in securing the support of U.S. Members of Congress on letters of support or other key communications between the Congress and the Bush Administration concerning ROC - U.S. relations.
5. Sen. Torricelli will assist TECRO with invitations to Members of Congress for events sponsored by TECRO or the ROC for events scheduled in the Washington D.C. area.

6. Sen. Torricelli will remain in contact with leaders and key members of the Congress regarding developments in Taiwan, with particular importance paid to events that underscore the important nature of the ROC - U.S. relationship and those developments that show the continuing progress of Taiwan in economic, social, and political matters.

On or before the 10th day of each month, Sen. Torricelli will submit a Monthly Activity Report of all activities undertaken on behalf of TECRO to the Representative. Sen. Torricelli has already requested that Abbe Lowell, Esq. of the Manatt, Phelps & Phillips Law Firm in Washington D.C. prepare the appropriate registration forms indicating the Senator's representation of Taiwan, R.O.C. before the U.S. government.
