Privacy Act Statement. 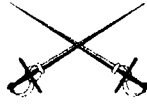

This Agreement will serve to confirm representation and consulting services to be provided by Scribe Strategies & Advisors (“Scribe”), located at 1660 L Street, NW, Suite 504, Washington, DC 20036, to the Embassy of the Republic of Korea (“Korea”), located at 2450 Massachusetts Avenue, NW, Washington, DC 20008.

(1.) Scope of Work: There are a number of key issues that are being considered by the Administration and Congress in the United States that affect the U.S.-Korea General Bilateral Alliance (“GBA”). Scribe is fully prepared to assist Korea with certain important elements of this broader GBA agenda. Specific issues to be addressed in light of the services to be performed will be communicated on a regular basis to Scribe as determined by Korea.

Scribe is a firm that has a deep commitment and abiding friendship towards Korea, with a unique perspective of understanding the complexities that govern the U.S.-Korea alliance partnership. We believe that our combination of skills and capabilities aligned with a personal “passion” for the issues will ensure Korea that Scribe effectively implements a program to elevate, broaden and strengthen the U.S. perception of the GBA between the two nations. We will seek to achieve this through strategic communication, public relations and policy education.

In our discussions, as Korea has identified the GBA services which it wants Scribe to provide under the form of advice, counsel, strategic consulting, media development and public relations advocacy, Scribe will itself register under the terms of the Foreign Agents Registration Act of 1937 (FARA), as amended, in order to fully comply with United States law. Furthermore, this Agreement shall be in full compliance with the Foreign Corrupt Practices Act and all other U.S. legal requirements.

(2.) The Scribe Team: The full resources of Scribe will be made available to Korea throughout the duration of this Agreement. Thomas S. Kim, Senior Vice President, will personally lead, oversee and manage the Scribe team, and he will be assisted by Joseph Szlavik, President, and other members of Scribe as needed or required. Biographies of all of Scribe’s Professionals will be provided upon request.

(3.) Fee & Expenses: With the abovementioned aim, Scribe will receive a retainer fee of US\$20,000 per month for a period of one (1) year for the described GBA services. The period will commence on January 1, 2007 and end on December 31, 2007. Quarterly payments in the amount of US\$60,000 will be made to Scribe and due on the first day of the first month preceding each three-month (quarterly) period. Wire transfer instructions will be provided in a separate document (Exhibit "A"), if necessary. In addition, Korea shall reimburse Scribe for certain extraordinary costs and expenses, including, printing, travel, lodging, special projects and out-of-pocket expenses undertaken by Scribe for Korea, provided that prior approval for such expenses shall have been confirmed by Korea in writing. Scribe promises to provide the services described in the preceding paragraphs of this agreement, under the management of Thomas S. Kim, assisted by Scribe professionals.

(4.) Confidentiality & Termination: Scribe fully recognizes that the subject matter regarding the scope of services requires the highest degree of confidentiality. Scribe acknowledges its responsibility, both during and after the term of this Agreement, to use all reasonable and legally permissible efforts to preserve the proprietary or confidential information developed by Scribe on behalf of Korea or disclosed by Korea to Scribe.

Either party may terminate this Agreement upon thirty (30) days prior written notice for any reason. If this Agreement is terminated by either party, Scribe will refund to Korea, the pro-rata share of any advanced quarterly payment of its retainer.
