The understanding between the registrant and the foreign principal has not been set out in definitive terms as it has only been agreed that the registrant shall hold office in the Italian Chamber of Deputies as a Deputy and member of the Forza Italia political party so as to represent Italian Citizens residing in North America. The duration of the understanding has not been set out in concrete terms, however, it is assumed that the duration shall be the length of the registrants holding of the elected office, normally 5 years. It is expected that the registrant shall receive a salary and monies for reimbursement of expenses incurred in connection with holding such office as a member of Italy's Chamber of Deputies, fair estimate is expected to be a monthly salary of \$6,000.00 and reimbursement of expenses up to \$12,000.00
