ANNEX II

to Memorandum of Agreement between Quinn Gillespie & Associates LLC ("QGA") and the Government of Republika Srpska, no. 04/1-2058/07, dated 24.12.2007.

Article 1

The parties agreed to extend validity of Memorandum of Agreement (from hereon referred to as: "Memorandum") between QGA and the Government of Republika Srpska for another 12 months, i.e. that it will be valid until 31.12.2010.

Article 2

In the article 2 of Memorandum (Fee Amount, Expenses, and Payment Schedule), section 1 is changed as follows:

- Instead: USD\$106,000 (one hundred six thousand U.S. dollars); the section will read: USD\$90,000 (ninety thousand U.S. dollars)
- Instead: USD\$16,600 (sixteen thousand six hundred U.S. dollars) ; the section will read: USD\$16,000 (sixteen thousand U.S. dollars)
- Instead: USD\$122,600 (one hundred twenty-two thousand six hundred U.S. dollars); the section will read: USD\$106,000 (one hundred and six thousand U.S. dollars)

Article 3

Parties agreed to add a new article to the Memorandum. The new article shall become an Integral part of the Memorandum and reads as follows:

"QGA is hereby obliged to provide publishing of at least three (3) media titles in U.S. media outlets each month. This can include public statements, topic specific articles, opinion editorials, or letters to editors in media like: *The Washington Post, The Washington Times, The New York Times, The Wall Street Journal, USA Today, The L.A. Times, The Chicago Tribune, AOL Money News, The Examiner, Reuters, Yahoo! Politics, The Washington Business Journal*, or other media outlets whose reputation is not lesser than that of the media listed above.


QGA is hereby obliged to submit monthly reports to the Government of Republika Srpska and present these and other activities it carried out in the name of Republika Srpska."




Члан 1.

Стране су се усагласиле да се рок, на који је закључен Меморандум о споразуму између QGA и Владе Републике Српске (у даљем тексту: Меморандум), продужи за наредних 12 мјесеци, односно да траје до 31.12.2010. године.

Члан 2.

У Меморандуму у члану 2. (Цијене услуга, трошкови и рокови плаћања), став 1. се мијења тако да:

- умјесто: *106.000 (сто шест хиљада US долара)*, треба да стоји: *90.000 (деведесет хиљада US долара)*
- умјесто: *16.600 (шеснаест хиљада шестстотина US долара)*, треба да стоји: *16.000 (шеснаест хиљада US долара)*
- умјесто: *122.600 (сто двадесет двије хиљаде шест стотина US долара)*, треба да стоји: *106.000 (стотину шест хиљада US долара)*

Члан 3.

Стране су се усагласиле да се у Меморандум дода нови члан који чине саставни дио истог, који гласи:

„QGA се обавезује да обезбиједи објављивање минимум три (3) медијска наслова у медијима САД, сваког мјесеца. То може да укључује саопштење за јавност, тематске чланке, ауторска писма и писма уредницима у медијима као што су: *The Washington Post, The Washington Times, The New York Times, The Wall Street Journal, USA Today, The L.A. Times, The Chicago Tribune, AOL Money News, The Examiner, Reuters, Yahoo! Politics, The Washington Business Journal* и медијима не мањег угледа од наведених.


QGA се овим обавезује да Влади Републике Српске доставља мјесечне извјештаје о овим и другим активностима предузетим у име Републике Српске.“

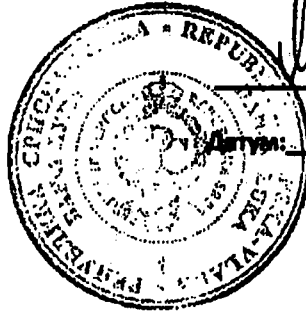


