

- 6. Johnson, Madigan, Peck, Boland & Stewart, Inc. will provide for The Executive Office of the Emirate of Dubai prior approval of all written documents that Johnson, Madigan, Peck, Boland & Stewart, Inc. plans to provide to public officials. The approval by The Executive Office of the Emirate of Dubai of any written document means that The Executive Office of the Emirate of Dubai represents that the document is accurate and authorized its public disclosure by Johnson, Madigan, Peck, Boland & Stewart, Inc. in accordance with The Executive Office of the Emirate of Dubai 's direction.
