

They also asked me to speak on their behalf to the media and public officials. They authorized me to speak on their behalf in the U.S. and attached is the letter, which states that they authorize me to be an official spokesman for the Iraqi Tawafuq Front, which is the Iraqi Parliament Coalition and includes the Iraqi Islamic Party and Vice-President Tariq Al-Hashimi. There are no fees at the present time and they have not paid me for any work. I do this on a special part time voluntary basis (when I have time). If in the future, they decide to pay me for any services, I will file an updated report.



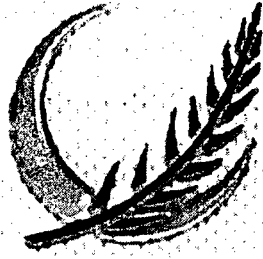
