Activities will consist of outreach to U.S. based journalists, sharing of press releases and background information, and coordination of speaking opportunities and interviews/briefings with journalists. The activities to be conducted in the United States will be directed by the Government Media Office. Activity is intended to have a general reputational impact for the client and is not intended to shape U.S. policy or regulation toward the UAE. The continued work in the United States on behalf of the United Arab Emirates is provided for in a new intercompany agreement between Registrant and FH UK, a copy of which is attached to this amendment.
