Dear Mr. Bill Pendergast:

This letter is to set forth the terms on which Fleishman-Hillard will provide media relations services to GrayLoeffler, LLC ("GrayLoeffler") with respect to its representation of the Levant Suez Consulting Corporation ("Levant") and Sheikh Fahad Salem Al Ali Al Sabah and the Fahad Al Salem Center for Dialogue Among Civilizations and Defense of Liberty's ("Fahad Al Salem Center"). The initial term of Fleishman-Hillard's engagement under this letter shall be through April 5, 2011.

Fleishman-Hillard will be providing a media relations program that will include three phases:

The first is a research phase where Fleishman-Hillard will develop messaging and from that, a pitch. The second phase is media outreach, securing interviews with national, business, and foreign policy reporters based in Washington, D.C. and New York, NY. Also, Fleishman-Hillard will be staffing these interviews and providing background materials. And finally, the third phase will be follow ups from interviews and packaging of all placements.

Billing Matters

The total fee for services provided by Fleishman-Hillard will be a fixed fee of \$20,000.00 (USD). GrayLoeffler will pay reasonable and customary expenses incurred by Fleishman-Hillard. For the purpose of this agreement, expenses shall include all reasonable expenditures for travel outside of the Washington, DC metropolitan area, meals, messengers, mail postage, freight and delivery cost, and duplication and printing costs. Fleishman-Hillard will not incur more than \$500 (individually or in the aggregate) in expenses without prior approval by GrayLoeffler. By signing this engagement, Fleishman-Hillard confirms its understanding of this agreement with the foregoing.

Fleishman-Hillard will invoice GrayLoeffler for 50% of the fixed fee upon execution of this Agreement. Said invoice shall be due 5 days after GrayLoeffler receives reimbursement of the relevant funds from Levant. Fleishman-Hillard will invoice GrayLoeffler for the final 50% of the fixed fee, as well as any expenses incurred, upon completion of the services to be provided hereunder and said invoice shall be due and payable 30 days from receipt. In no event, will Fleishman-Hillard's invoices be paid more than 30 days after the completion of the services provided under this Agreement.

By signing this engagement agreement, all parties confirm their understanding of and agreement with the foregoing.

Other Matters

Neither party shall have any liability to the other for any lost profits or special, incidental, indirect or consequential damages, even if advised of the possibility of such damages. In addition, GrayLoeffler shall not be liable for any liabilities, costs and expenses incurred or suffered by reason of, or in any way relating to, this engagement other than as judicially determined to be caused by GrayLoeffler's own bad faith, willful misconduct or negligence.

Fleishman-Hillard will comply with all federal and state laws and regulations applicable to lobbying and any other activities undertaken on behalf of GrayLoeffler, Levant, Shiekh Fahad or the Fahad Al Salem Center, including, but not limited to, the Lobbying Disclosure Act of 1995, as amended by the Honest Leadership and Open Government Act of 2007, as well as the Foreign Agent Registration Act, and any other applicable laws and regulations.

This agreement may be amended only by an instrument executed by the parties.


