



In this regard, Gray Global Advisors, LLC will provide services related to MACP's activities to positively affect relations between Morocco and the United States.




Please note that this agreement will expire on December 31, 2014. Either party may cancel or change the terms of this agreement with a 30 day written notification delivered to the principal location of the other party.
