

Registrant has a verbal agreement with the Embassy of Japan by which the Registrant will provide ad hoc research and advice on political and public policy questions posed by the Embassy, and is anticipated to focus on areas of international and U.S. trade policy and general U.S. government policy. The verbal agreement was reached on May 15, 2014. Services are to be performed from June 1, 2014 through March 31, 2015. Fees for the ad hoc research and advice are anticipated to be approximately \$20,000. No expenses shall be reimbursed by the Embassy for costs incurred by the Registrant.

8. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Registrant will provide ad hoc policy research and advice in response to specific questions that may be posed by the foreign principal from time-to-time, focused largely on U.S. and international trade policy and U.S. government policy generally. No outreach or advocacy with U.S. officials or U.S. media will be performed by registrant.
