

Prism Public Affairs will help the Taipei Economic and Cultural Representative Office with its media outreach efforts. We will work at the direction of TECRO and C&M Capitolink.

Prism Public Affairs will work mostly with print and broadcast media. Prism is not promoting any legislation in particular. Prism will work with TECRO and the media regarding upcoming elections and a referendum regarding joining the United Nations. Prism may also support efforts by C&M Capitolink on behalf of TECRO regarding approval of F-16 military aircraft sales to Taiwan and that proper cartography standards be used by publications with identifying Taiwan as a separate political entity from other nations in the region.
