We may meet with or otherwise discuss, our media outreach efforts with United States Government officials. We are working mostly with print and broadcast media, but may look to government officials to augment those efforts. We are not promoting any legislation in particular, but will encourage efforts for approval of F-16 military aircraft sales to Taiwan and that proper cartography standards be used by publications with identifying Taiwan as a separate political entity from other nations in the region.
