While a new contract is being negotiated, the registrant will provide services to the foreign principal on an interim basis pursuant to the terms and conditions of the contract that expired on December 31, 2020 (a copy of that contract is already on file with DOJ). The registrant will submit a new contract and revised Exhibit B when an agreement on the terms has been reached.

The Fratelli Group will provide media / public relations consultancy services including: message and materials development; media and public outreach support; event management and coordination; media monitoring and news analysis; and strategic counsel.

Consulting services to be rendered include: message and materials development; media and public outreach support; event management and coordination; media monitoring and news analysis; and strategic counsel. This may include:

- Developing communications strategies
- Developing key messages
- Contacting members of the media
- Coordinating interviews with members of the media
- Contacting members of the general public regarding Colombia-related events
- Drafting materials, including: event invitations, press releases, media advisories, fact sheets, etc.
- Coordinating and managing events
- Monitoring news of interest to the foreign principal
- Providing advice and counsel on media strategy

The Registrant's activities on behalf of the foreign principal will focus on media monitoring and counsel, as well as raising awareness and deepening understanding of Colombia as a longstanding strategic partner of the United States among key stakeholder groups, including the U.S. government and its agencies, Congress, media and thought leaders. These activities may include communications with representatives of various media on behalf of the Government of Colombia relating to legislation and congressional actions, and actions by the Executive Branch and U.S. government agencies that may affect or relate to the interests of the foreign principal.
