

Communicate with members of the Administration regarding support of Moise Katumbi's return to the Democratic Republic of Congo (DRC) and his participation in the political process in the DRC.



Dear Marc:

Blueprint Communications, LLC, has chosen to retain Brownstein Hyatt Farber Schreck ("BHFS") to provide government relations support for our work on behalf of Gabara Strategies of London. The purpose of this letter is to set forth our mutual understanding as to the terms and conditions of this engagement.

Description of Services. BHFS will provide government relations support to Blueprint Communications on behalf of Gabara Strategies and their client, Moise Katumbi. Mr. Katumbi is a citizen of the Democratic Republic of Congo, currently living in Belgium. Specifically, these services will include outreach to senior officials of the Trump Administration's foreign policy team, including:

- The National Security Council
- The U.S. Department of State
- The U.S. Department of Defense

The purpose of this outreach is to:

1. inform policymakers about the political situation in the Democratic Republic of Congo;
2. build support for aligning U.S. policy with the rest of the international community to require the government of the Democratic Republic of Congo to allow Mr. Katumbi to return to his country and participate in the political process securely and fairly; and
3. support any visit(s) to Washington, D.C., by Mr. Katumbi, including direct meetings between him and appropriate Trump Administration officials.

Fee Amount, Payment Schedule and Term. In consideration for the services to be rendered under this agreement, Blueprint Communications shall pay BHFS a fee of \$20,000 per month for an initial two-month engagement. The first invoice can be issued upon execution of this agreement with the second invoice to be issued 30 days later. Payment will be made within 15 days of the receipt of each invoice.

Waiver. During the term of this agreement, BHFS shall notify and consult with the Blueprint Communications in advance of accepting any matter known by BHFS to be potentially adverse to Blueprint Communications in matters related to its work for Gabara Strategies and Mr. Katumbi.

Confidentiality. Except as necessary for the performance of the services contemplated herein or with Blueprint Communication's specific consent, BHFS shall keep confidential all information received from the Blueprint, its affiliates or representatives. BHFS's obligation to keep information confidential shall survive the termination of this agreement.

Miscellaneous. Work done under this agreement will require public registration under either the Foreign Agents Registration Act (FARA) or the Lobbying Disclosure Act (LDA). BHFS is responsible for determining which reporting requirements are applicable and for completing those requirements in a complete and timely way.


