

Dear Counselor Myounsun Kim:

The purpose of this letter is to supplement and amend that certain Retainer Agreement with Embassy of the Republic of Korea (the "**Client**") and that certain Amendment to Retainer Agreement dated February 9, 2022 (collectively, the "**Retainer Agreement**"), between Brownstein Hyatt Farber Schreck, LLP ("**Brownstein**") and the Client.

Upon execution of this letter by all parties to the Retainer Agreement, effective as of July 1, 2024, the Retainer Agreement shall be further amended as follows:

- The term of the Retainer Agreement is extended to December 31, 2024, at which point it will renew for an additional six month term barring a new arrangement;
