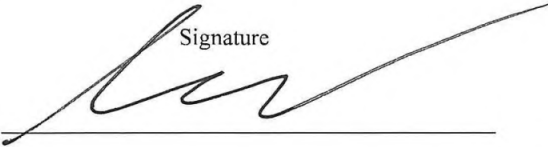

We refer to the Agreement for Policy Services between TPCL and Brownstein dated 26 June 2024, and subsequent Amendment Letter dated 28 January 2025 relating to Phase II Services and the reduced retainer fee for the period 1 February to 1 August 2025.

Capitalised terms defined in the Agreement have the same meaning when used in this letter, unless the context of this letter otherwise requires.

We hereby request that the Agreement be further amended as follows: the reduced Monthly Retainer Fee of USD 85,000.00 (eighty-five thousand US dollars) payable to the Firm by TPCL shall continue to apply for an additional period of six months, commencing on 1 August 2025 and ending on 1 February 2026.

All other terms and conditions relating to the Phase II Services, as set out in our previous Amendment Letter, shall remain unchanged and continue in full force and effect during this extension period.

This letter and any non-contractual obligations arising out of or in connection with it are governed by English law.
