
Dear Minister Choi:

This extension and Amendment is pursuant to Articles 4.2 and 10.1 of the Consulting Agreement.

The Consulting Agreement is hereby extended through July 31, 2009, and Article 4.1 is modified accordingly. The fees provided for in Article 12.1 are hereby amended to consist of US\$10,000 per month. All other terms of the Consulting Agreement shall remain in force as originally provided.


